Leisure Services – West

Ribbon cutting for Carr’s Creek section this morning.

Large sign made for 20th anniversary of the Greenway at SCNC. Took down because was more than a year old.

SPLOST update almost a month ago. Oak-Oconee overpass stream buffer paperwork is being finished.

Greenway approaching SCNC—in process of receiving bids. Work will be August to January.

Cemetery—People are hopping over the bridge to get to cemetery. Will be some panels going up. Trees have taken out part of the fencing in a couple of places.

Greenway South— Soil collapsing under Greenway between Loop and North Oconee. Trying to figure out what is happening.

New member approval—trying to get it on the Mayor and Commissioner’s meeting agenda for May; June if that doesn’t work. City thinks that a partial term counts as a

full term, and that there has to be a break after a partial and full term. This is not the way it has been done in the past.

When someone departs from commission need an updated mailing address. City wants to send something, In the past chair writes a letter, goes to the county, then they send it.

MLK TSPLOST section. Got funded last round. On priority list but below government center. May be out for bid now for engineering.

Firefly trail gap in Winterville. May still be negotiating a few parcels. Seems like there are a few properties left. Could reach out to Derrick Doster at SPLOST office.

Sustainability Office – Greene

Put on your calendars. May 29 we will have a celebration at Dudley Park as far as the GOS grant. Time may be 11:30. Towers being painted. Bluebirds in one of the bluebird boxes. Also chickadee hatchlings in one box.

MLK to College Ave section. People are confused how to get to Dudley Park from there. She gets asked that question regularly when out on the Greenway.

Planning – Prichard

Nothing to report.

Charlie asked where to submit the comment on the land use map. Wick will send to Charlie.

Property buyers of a tract need to know if potentially a Greenway will come through. Daniel: Noticed that sewer easements were on the map, but not the Greenway. Need to make sure they are aware of that. Leisure Services is brought on for projects that impact the Greenway.

Stephanie: FYI. Will be activity on MLK, will resurvey property line and after that a fence will go up. From MLK to the Greenway to demarcate private property from city property.

Transportation and Public Works (TPW) – Sizemore

A few things are coming up, nothing specific for the Greenway. Conversations about data and access to GIS. Story map could be built on ACC account.

Crossing Willow and Broad. Crosswalk. To give pedestrian more visibility. Request near Nellie B that requires more design. Crosswalks now pedestrian generated, no

longer need to do counts. 20 crosswalk backlog. Got some extra funding. All the ones related to parks and leisure services are marked.

Public Utilities – Ogle

Bike Athens – Long

Missing tool at East Campus connector fix it station. Replaced them. Rose: pump was pulled apart.

Friends of the Greenway: Current Friends board want information about new board, Finishing that up.

Firefly Trail – Keene

Ticket to ride very successful. 200 people, good weather. More sponsors than before; did well financially

Received grant to finish paving in Maxeys.

Didn't get Crawford grant from GOS. There is broader Interest in having more of GOS money go to trails; Parks get most of the money, Would like to generate support for trails to become a bigger part of the GOS grants. This is an ambition for the future, since it is the one state fund that should continue to be there.

Working on a federal grant to do planning and engineering for all of Oglethorpe County. In meantime, hope to do more model miles with smaller amounts of money.

Greene: Just finished a GOS project for Dudley—all new improvements part of the Restore Rivers GOS gena. Just wrapped up. County has taken advantage of GOS Grants

Oconee Rivers Audubon Society (ORAS) – Maioriello

Bird walk Saturday morning at Greenway. Meeting at UGA E23 lot.

27th Walk at Sandy Creek Park

28th will be out at the landfill.

Oconee Rivers Land Trust doing a walk Thursday at property in Jackson County.

Northeast Georgia Regional Commission – Mark Beatty

Going through voluntary update of regionally important natural resource management plan. ORGC already listed.

Ribbon cutting this morning was almost at his office. Leisure Services uses counters that don't show directionality. He has a few that do, Will put one out as a tester. Free lending of counters to local governments. Will put one on Carr's Creek section.

There is already a contract with Bike Athens to maintain these.

Interest in going south through Madison along the Athens Line. Goes Downtown form transit center, through Watkinsville, on down to Madison,

Working with Jackson County on master plan connecting trails from Athens to there.

New Business

Dpoherty: Any updates about Beech Haven? Nothing since we submitted our recommendation. Hotel proposed on Atlanta Highway—adjacent to Beech Haven. 3 conditions attached to it. Hasn't come through planning process. Just a request for rezone.
