Project 3: 9:30 AM	Sunny Healthy GA, Inc 1855 W Broad St PR-2023-05-0868	Interior renovation of existing building for a massage business.
Project 4: 10:00 AM	Acumen, LLC 125 W Washington St PR-2023-05-0869	Interior renovation of existing office space for a new office user & business in Suite 700 (on seventh floor)
