

You may be excused from jury duty or deferred for jury duty if:

You are 70 years or older and do not wish to serve. If you ask to be excused for this reason, your name will be removed from the jury list.

You are the primary caregiver for, and have active care and custody of, a child six years of age or younger and have no reasonable available alternative child care.

You are a full-time student at a college, university, vocational school or other postsecondary school and are enrolled and taking classes or exams.

You are the primary teacher in a home study program as defined by law and have no reasonable available alternative for the child or children in the home study program.

You are the primary unpaid caregiver for a person over the age of six with physical or cognitive limitations that prevent the person from caring for themselves and have no reasonably available alternative to provide for the care.

You are a service member on ordered military duty or the spouse of a service member on ordered military duty.

You are not eligible to serve as a juror if:

You do not reside in Athens-Clarke County.

You are not a citizen of the United States

You cannot speak or understand English.

You have been convicted of a felony and have not had your civil rights restored.

You have been judicially determined to be mentally incompetent.

If you are requesting to be excused from jury duty or requesting to be deferred for jury duty, or if you are not eligible to serve as a juror, please complete the affidavit on the reverse side of this page, have your signature notarized, and send the affidavit and any necessary documentation in support of your request to:
