



# Stormwater Bankdraft Program

The bankdraft program is a service offered to all Athens Clarke County Stormwater customers. It allows your checking or savings account to be automatically debited each year for the amount of your Stormwater Utility Fee on the due date shown on your bill.

To begin taking advantage of our free bankdraft program, simply fill out the form below and attach a voided check. After our office receives your completed application, we will authorize your withdrawal with your financial institution, and you will be enrolled for any subsequent billing periods.

After the initial set-up period (verification from your bank takes 30 days) you can expect to receive a notification on an **annual** basis through the mail informing you of the amount of your Stormwater Utility Fee, as well as a notice of intent to draft your account for the **annual** fee. This will eliminate the need to write checks, saves postage and, most importantly, saves your valuable time.

## **Frequently Asked Questions**

- **What if there is a problem with my bill?**

Call us! Our telephone number is **706-613-3440**. We will check your account and make any necessary adjustments as well as reconcile changes with the bank. If you have any questions, our Customer Service Representatives are always happy to assist you.

- **What if there isn't enough money in my account to cover the bill?**

The draft is treated as a check by your bank and the Stormwater office. If there is not enough money in the account to fund the draft on the due date, the draft will be treated as an insufficient item and return check fees are then incurred.

- **Will I need to sign up for the Bankdraft Program each year?**

No, however, if any of your banking information changes you will need to complete a new form, and we will need a voided check from your new account to verify with the bank.

- **What if I wish to stop participating in the Bankdraft Program?**

The Stormwater office will need at least a 30-day written notice to stop drafting funds from your bank account. Please call our office at (706)613-3440 for a Cancellation Form.
