



## Athens-Clarke County Leisure Services Department Alcohol Usage Permit

### Terms of Permit

1. Requests for a Leisure Services Department Alcohol Usage Permit must be made in conjunction with a Leisure Services Department facility rental or special event permit.
2. Staff reserves the right to limit an individual, group or organization to a maximum of two (2) Leisure Services Department Alcohol Usage Permits per calendar year. The Director of Leisure Services, or designee, shall have the discretion to deny any application for a permit based upon a review of the applicant's history with events at Leisure Services facilities, the potential use of Athens-Clarke County resources associated with a proposed event, conflicts with regular operation of Leisure Services facilities, and any other factor that the Director of Leisure Services finds relevant under the circumstances to protect the health, safety and welfare of the public and public resources.
3. Beer and wine are the only alcoholic beverages that may be dispensed, distributed or consumed. Liquor is prohibited. The use of glass containers in outdoor settings is prohibited.
4. Alcohol shall not be dispensed, distributed or consumed in excess of four (4) hours for any permitted event. Such period shall be indicated below in the "Event Start Time/End Time" section.
5. Alcohol may only be dispensed, distributed or consumed in areas of the facility and at hours designated by the Athens-Clarke County Unified Government (ACCUG). Occupancy limits may not be exceeded at any time. Possession or consumption of alcoholic beverages beyond the limits of the defined areas is not permitted. Athens-Clarke County's open container ordinance will be enforced in areas outside of the defined limits where alcohol may be possessed or consumed. Leisure Services Department staff will be on-site for the duration of the rental or event to enforce the permit requirements as needed.
6. Any public event in an ACCUG Leisure Services Department facility that will include dispensing and/or distribution of alcohol requires the use of a licensed alcohol caterer as defined in the Code of Ordinances for Athens-Clarke County Sec. 6-3-1. It is the Applicant's responsibility to ensure that all required licenses and permits are in order, and to provide proof of licenses and permits prior to the event.
7. Any private event with an expected attendance of more than 25 persons that will include dispensing and/or distribution of alcohol will also require the use of a licensed alcohol caterer as defined in the Code of Ordinances for Athens-Clarke County Sec. 6-3-1 or a food caterer providing bartender services only as provided in Leisure Services Department Alcohol Policy, a copy of which is attached hereto. Any event with alcohol that includes only private participation requires that possession, dispensing and/or consuming of alcohol be permitted only by attendees of the private rental.

8. Depending on the size of event, the anticipated number of participants and its potential impact on public services, staff reserves the right to require that a background check of the Applicant be performed by the ACCUG Police Department to ensure the safe operation of the event. Background checks will be at the expense of the Applicant.
9. Applicant, or any caterer, bartender or agent of Applicant, must direct those dispensing alcohol that they shall not provide alcoholic beverages to any person who appears to have consumed an excess amount of alcohol, and that those dispensing alcohol are responsible for verifying the age of all persons who will consume alcohol, and to whom alcohol is dispensed.
10. Applicant shall be prepared to provide transportation through a designated driver or commercial taxi service in the event that person dispensing alcohol has reason to believe any person has consumed alcoholic beverages in excess of the legal limits and intends to operate a motor vehicle. ACCUG reserves the right to remove or have removed from the facility any person for same reason.
11. ACCUG reserves the right to require off-duty Athens-Clarke County Police Department officers for groups consuming alcohol, the direct costs of which will be paid by the Applicant prior to the rental or event. The number of officers shall be determined by the Chief of Police.
12. Applicant acknowledges that its activities may be inspected at any time by ACCUG staff and authorities, including law enforcement, to ensure compliance with all legal requirements.
13. Applicant assumes liability for all damages to ACCUG property caused by any member of the group whether accidental, willful or the result of carelessness or negligence. Any damages shall result in the loss of security deposit in part or in full. Applicant acknowledges that a security deposit may not be sufficient to pay for such damages and that Applicant shall be responsible for all costs for damages that may be greater than the security deposit.
14. ACCUG reserves the right to require liability insurance with ACCUG named as additional insured. ACCUG may also require a refundable security deposit equal to half of the total event fees.
15. ACCUG authorities have the right, without refund, to terminate the dispensing of alcoholic beverages or to terminate the event if any requirement or condition of this permit is violated or if the conduct of participants of the event poses a danger to the health, safety and welfare of the public or to public property.
16. The designated areas in the facilities noted will be allowed for dispensing and consuming

16. Outdoor designated areas within a special event where alcohol is permitted shall be securely enclosed on all sides by a fence, barricade or other similar such structure approved by Department staff so as to completely separate that area from the areas in which alcoholic beverages are not permitted. The total area may not exceed 4,000 square feet.

**Permit Fees:**

**The following fees apply to all above facilities except the Lyndon House Arts Center (LHAC) and the Morton Theatre. Alcohol permit fees for the LHAC and Morton Theatre are factored into existing rental fees at this time.**

Location	Size of Event	Cost
Outdoor Event	Serving Area of no more than 2,000 sq. ft.	\$150
Outdoor Event	Serving Area of no more than 4,000 sq. ft.	\$300
Indoor Event	Less than 50 attendees	\$50
Indoor Event	More than 50 attendees	\$150
